Higher Education Emergency Relief Fund Disclosure

Updated September 30, 2021

South Hills School of Business & Technology (SHSBT) has been allocated funding from the Higher Education Emergency Relief Fund (HEERF), which is part of the Coronavirus Aid, Relief, and Economic Security Act (CARES Act), that was enacted on March 27, 2020. Sections 3504, 18004, and 18008, allow higher education institutions to use certain funds allocated by the Department of Education to support students and higher education institutions with expenses and financial needs related to the coronavirus (COVID-19) pandemic.

Amounts were calculated based on the number of Pell Grant Recipients and full-time equivalent enrollment at each institution. South Hills has been allocated \$795,265 half of which is required to be distributed directly to students who are experiencing hardship due to the COVID-19 pandemic.

Being aware of the hardships facing our students, SHSBT moved swiftly and applied for these funds almost immediately after becoming available. SHSBT appointed a HEERF team comprised of the President, Campus Directors, and Director of Regulatory Affairs, Bursar, and Financial Aid. The HEERF team established eligibility criteria, developed a timely and efficient request and approval process, attended multiple training sessions, and ensured compliance with all reporting requirements. Within 48 hours of SHSBT receiving the funds, students were able to request their grant money allotment through an electronic request system.

In compliance with disclosure and reporting requirements, SHSBT has made the following information available:

Were there any additional instructions, directions, or guidance provided by the institution to students concerning the Emergency Financial Aid Grants?

Several emails and texts were sent to students to encourage them to apply for the CARES Grant funding. The instructions were straightforward and students were able to access the application from the South Hills website

HEERF II

The Higher Education Emergency Relief Fund II (HEERF II) was authorized by the Coronavirus Response and Relief Supplemental Appropriations Act, 2021 (CRRSAA), was enacted on December 27, 2020. Congress created several programs within HEERF II. South Hills School of Business & Technology is in the Proprietary Institutional Grant Funds for Students Program 84.425Q Section 314 (a) 4. South Hills will receive it's grant funding in the amount of \$406,137. We will distribute the funds to our students when additional (COVID-19) hardships occur. The method for distribution will be the same as reported in HEERF I. As of September 30, 2021, there have been no funds distributed.

HEERF III

The Higher Education Emergency Relief Fund III (HEERF III) was authorized by the American Rescue Plan and signed into law in the Spring 2021. South Hills will receive it's grant funding in the amount of \$239,991. We will distribute the funds to our students when additional (COVID-19) hardships occur. The method for distribution will be the same as reported in HEERF I. As of September 30, 2021, there have been no funds distributed.
